- Reminder all dogs must be on leash this is a King County Law as well as our policy in our HOA Parks.
- More bags of household garbage were put in our cans again at CR Park two weeks in a row now. I also found more stolen mail.
- A CW Homeowner has asked why we do not fix the cement slab and put up new Basketball Hoops at CW Park.
- King County Sheriff Patrols and requests will now be coordinated by the CAM Chair and monthly reports will be submitted before each monthly meeting. Please contact the Board with any areas of concern and we will do our best to accommodate.

Reminder: Our parks are private parks which exist for the use and enjoyment of HOA residents, their families and guests. They are not public parks. Our park usage rules apply to everyone. - C. Animals must be leashed and owners are responsible for cleaning up after their animals.
